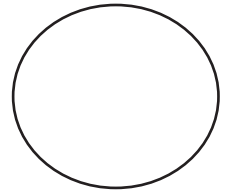

Dear Prospective Chicken Show Vendors,

The 43rd Annual Chicken Show in Wayne, Nebraska will begin on Friday, July 7 with a downtown Clucktique Sidewalk Market on the sidewalk from 10 am to 3pm, and struts into the evening with Henoween activities in the street from 5 pm- 10 pm. Saturday Events cluck their way to Bressler Park from 8 am to 5 pm on July 8 and hatch at the Last Cluck on Sunday, July 9.

Whether you are a new vendor or have been here before, please review the 2023 vendor materials as the committee continues to make changes to improve the event for you and for our guests. The completed Registration Form must be returned with all applicable fees by **May 31, 2023** to reserve your booth space.

Vendors will be set up in three basic categories:

1. Food Vendors - grouped in the Food Court area, with access to electrical service.
2. Non-food vendors - no access to electricity and generators will not be permitted. VENDORS ARE PROHIBITED FROM SELLING ANY T-SHIRT ITEMS.
3. Kid Zone - children's games, contests, and activities.

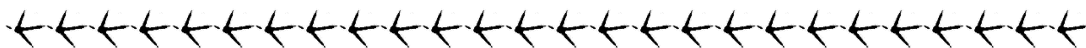

GENERAL VENDOR INFORMATION AND CONDITIONS

Vendors may have limited maneuverability due to narrow city streets. Vendors WILL NOT be assigned a location prior to the event. Upon arrival, vendors must first present themselves to event staff, before beginning any set-up. It is important that each vendor set-up in the specified location and staff reserves the right to make location adjustments for the good of the event.

-**Clucktique Sidewalk Market** is located on the downtown sidewalks between 2nd and 3rd street Friday July 7 from morning to early afternoon. **Clucktique Sidewalk Market Vendors are limited to space for two (2) 8 FT tables and must provide your own.** Vendors will not be allowed to block store fronts or the sidewalk and any canopy or shade structure must fit inside the reserved space. Set-up begins at 8 am. Clucktique only Vendors must be cleared from the sidewalks and all vehicles removed at 3 pm when the street is closed for **Henoween**.

-**Henoween** takes place Friday evening July 7 on the streets of downtown Wayne. Set-up begins at 3 pm after the street has been closed. **VENDORS WILL NOT BE ALLOWED TO SET-UP AFTER 4:30 PM!** Main Street will be closed to traffic and parking. Vehicles should be unloaded and promptly moved to designated vendor parking. Shared generators will only be available in the Food Court area.

-**Saturday** events will take place July 8 in Bressler Park at 10th and Lincoln. Set-up is from 7-9 am. **VENDORS WILL NOT BE ALLOWED TO SET-UP AFTER 9 AM!** Tear down is from 4-6 pm.

Free overnight parking is available Friday night on the WSC campus in the east half of Lot #10.

Food Vendors are required to be licensed by the State of Nebraska through the Nebraska Department of Agriculture. To get a temporary license, contact Jeff Hall at 402-471-3422.

YOU CAN EXPECT TO SEE A STATE INSPECTOR WHO WILL BE CHECKING FOR LICENSE DOCUMENTATION!

- ✚ A hand sink with hot and cold running water, 3 – unit sink with drain boards for utensil washing.
- ✚ Hot foods at 140° F minimum and cold foods at 45° F maximum.
- ✚ On hand metal-stem, bi-therm product thermometer and a sanitizer test kit.
- ✚ Food prep areas properly screened and light bulbs protected against breaking.
- ✚ Wastewater disposed of properly and not allowed to drain on the ground.
- ✚ Food grade hose used for potable water.
- ✚ Ice must be covered and ice bins continuously drained to prevent standing water.
- ✚ Food stored six inches above floor level.
- ✚ Food handlers' hair effectively restrained with hats, nets, or caps.
- ✚ Single-service cups dispensed from cup dispenser.

- ✚ Limited generator capacity is available. If you have your own individual generator that runs quiet please send additional information
 - ✚ You will be responsible for providing your own extension cords.
 - ✚ Vendor spaces are assigned in approximate **10x20 FT** increments.
- ✚ Please be sure to check in with event staff upon your arrival for additional last minute instructions
 - ✚ and to confirm your location.
 - ✚ We reserve the right to make logistical changes for the good of the event.
 - ✚ Please note that you must **SET UP ON TIME.**
